The Nuclear Medicine Technology program at Baptist Health Sciences University is accredited by Joint Review Committee on Educational Programs in Nuclear Medicine Technology (JRCNMT). Students successfully completing all nuclear medicine technology degree requirements will receive a Bachelor of Health Sciences (BHS) degree with a major in nuclear medicine technology. They are eligible to apply to sit for the national exams in nuclear medicine technology administered by either the Nuclear Medicine Technology Certification Board (NMTCB) or the American Registry of Radiologic Technologists (ARRT). Upon earning credentials as a nuclear medicine technologist by either of these credentialing agencies, graduates who have successfully completed the required Computed Tomography (CT) clinical competencies are also candidates for the ARRT (CT) registry. Graduates who have completed the required CT clinical hours and clinical competencies are also eligible for the NMTCB (CT) certification exam. Additional requirements for licensure may be required by the state in which you practice.
