The Baptist Health Sciences University Surgical Technology program is accredited by the Commission on Accreditation of Allied Health Education Programs (CAAHEP) upon the recommendation of Accreditation Review Council on Education in Surgical Technology and Surgical Assisting (ARC/STSA). Students successfully completing all surgical technology degree requirements will receive an Associate of Science (AS) degree in Surgical Technology and are candidates to sit for the national examination to become a Certified Surgical Technologist through The National Board of Surgical Technology and Surgical Assisting (NBSTSA). Passing the national examination qualifies the individual as a Certified Surgical Technologist (CST[®]). The Association of Surgical Technologists (AST) recommends that all surgical technologists obtain this certification and retain this credential throughout their professional career. Additional requirements for licensure may be required by the state in which you practice. To apply for the Certified Surgical Technologist certification, one must graduate from a <u>CAAHEP</u>- or <u>ABHES</u>- accredited program or be military-trained.
